

The Governing Body of the concerned Educational Agency/Principal-Cum-Secretary shall also be liable to refund the amount received by him/her within a stipulated time and in case of failure to refund, the same shall be recovered as per the provisions of Odisha Public Demands Recovery Act, 1962.
